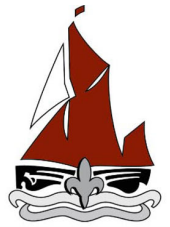

Description

The structure is a square three span brick arch with brick piers, abutments, spandrels and parapets. There are several transverse fractures in the arch barrels, particularly in the two side spans, with recent movement opening one resulting in the closure of the road over to prevent overloading leading to collapse. There is a public right of way (PRoW) which passes beneath the centre span of the structure. It is proposed to install a corrugated steel arch beneath the centre span infilling the surrounding void with foamed concrete. The side spans will be filled with structural granular fill and foamed concrete. This will maintain access for the PRoW beneath the structure whilst supporting the bridge and road above. For further details on the proposed works please refer to the design and access statement and drawings provided with this application.

The structure carries an unclassified road, Church Lane, over the former Maldon to Woodham Ferrers Railway line. There is now a Public Right of Way which passes beneath the centre span of the bridge. Recent movement has caused a new transverse fracture to open and therefore the road over has been closed due to safety concerns.

Corrugated steel arch installed beneath the centre span fixed to concrete foundations. Centre span is to be infilled with foamed concrete. Side spans are to be filled with 6N granular and foamed concrete once placement of 6N fill is not longer practicable. New embankment each side at a 1 in 1.5 gradient are to be formed from 6N granular material and finished with 150mm top soil which will be planted with a mixed scrub habitat.
